WHAT DOES U.S. CAPITAL ADVISORS LLC DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and other identifying information
- risk tolerance and investment objectives
- income and assets

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons U.S. Capital Advisors, LLC chooses to share; and whether you can limit this sharing.

What we do

How does USCA protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does USCA collect my personal information?

We collect your personal information, for example, when you

- open an account or direct us to buy and sell securities
- submit ID verification or provide contact information
- make a wire transfer

We also collect personal information from others, such as our affiliates, consumer reporting agencies including Equifax, Lexis Nexis, our clearing firm, and more.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include USCA Securities LLC, USCA RIA LLC, USCA Investment Holdings LLC, USCA Insurance Agency LLC, USCA Municipal Advisors LLC, USCA Asset Management LLC and USCA Family and Executive Services LLC.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies

- USCA does not share your personal information with nonaffiliates.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- USCA does not engage in joint marketing with nonaffiliates.

Other important information

USCA reviews our privacy policy annually and will provide a current privacy policy to our clients at the time a new account is opened and on an annual basis thereafter. USCA maintains relationships with the following clearing organizations:
